

## Vocational Rehabilitation Benefits for Veterans Includes New Programs

Jobs are on everybody's minds these days. When you veteran dealing with service-connected disabilities, there are challenges and opportunities to finding a job. One such opportunity is the Vocational Rehabilitation and Employment Program, which assists Veterans with service-connected disabilities to prepare for, find and keep suitable jobs. You may hear it referred to as the Chapter 31 program, and it was authorized by Congress under Title 38, Code of Federal Regulations, Chapter 31. For veterans with service-connected disabilities so severe that they cannot immediately consider Vocational Rehabilitation offers services to work. improve their ability to live as independently possible. Services offered include: •Comprehensive rehabilitation evaluation to determine abilities, skills and interests for employment • Vocational counseling and rehabilitation planning for employment services • Employment services such as job-training, job-seeking skills, resume development and other work-readiness assistance.



Assistance finding and keeping a job, including the use of special employer incentives and job accommodations
On the job training, apprenticeships and non-paid work experiences
Post-secondary training at a college, vocational, technicalor business school
Supportive rehabilitation services including case management, counseling and medical referrals
Independent living services for veterans unable to work due to the severity of their disabilities

Active-duty service members are eligible for the program if they expect to receive an honorable discharge upon separation from active duty, obtain a memorandum rating of 20 percent or more from the Veterans Administration apply for Vocational and Rehabilitation and **Employment** Services. Veterans are eligible if they have received, or will receive a discharge that is other than dishonorable and have service-connected disability rating of at least 10 percent Vocational and apply for Rehabilitation and Employment services.

The basic period of eligibility in which services may be used is 12 years from the date of separation from active military service, or the date the veteran was first notified by VA of a service-connected disability rating. The basic period of eligibility may be extended if a vocational rehabilitation counselor determines that a veteran has а serious employment handicap. Veterans may apply for this benefit at our offices. A brand new benefit to help certain veterans who are not in other programs training and find employment is The Vow to Hire Heroes Act of 2011 that was passed by Congress to provide assistance for unemployed veterans. If you are an unemployed veteran between the ages of 35 and 60 you might qualify.


